In case of fee recalculation currencies exchange rates are applied according to CBR rate at the date of operation.
 In case of recalculation of the plastic card operations Bank rates at the date of operation are applied. In case of conversion of operation from the currencies of the account to the currencies of the payment system additional commission is 1,5% of the operation amount is taken.
 Standard limits are: for cash withdrawal through ATMs – 2000 USD / 2000 EUR / 60000 RUB depending on the account currency per day, for payments – 10000 USD / 10000 EUR / 300 000 RUB depending on the currency of the account per day
 Bank provides not more than 100 authorizations per day
